

## **Minutes of North DeKalb MTA meeting February 18, 2010**

-Kathy Ackermann called the meeting to order at 10:20 a.m. at Cooper Music's Liberty Theatre.

-The minutes of the January 2010 meeting were read and approved.

-Margaret Liu presented the Treasurer's Report. Margaret reported the income realized this past month was from the Music Marathon and Ensemble Olympic events.

### **Speakers' Fees for Meetings:**

Lois brought to everyone's attention the fact that some other chapters pay more to the speakers for their programs. Lois suggested that we pay two-hundred dollars to each speaker for the program he/she presents. Margaret pointed out that there is a limit to that expense in our by-laws. For the by-laws to be changed, there will need to be a formal proposal presented and then voted by members. The second round is scheduled for Tuesday, April 20, 2010 at Berkmar High School with the orchestra starting at 7:15 p.m. for all six soloists.

### **New Business:**

#### **Bach Competition**

Gayle motioned for Glen to draft a proposal for an additional \$1,000 to be awarded as prizes for all categories in this year's Bach Competition. The total amount to be considered now is \$2,500 for cash awards. Kathy seconded and the motion passed. The committee is Glen, Lois, and Margaret.
